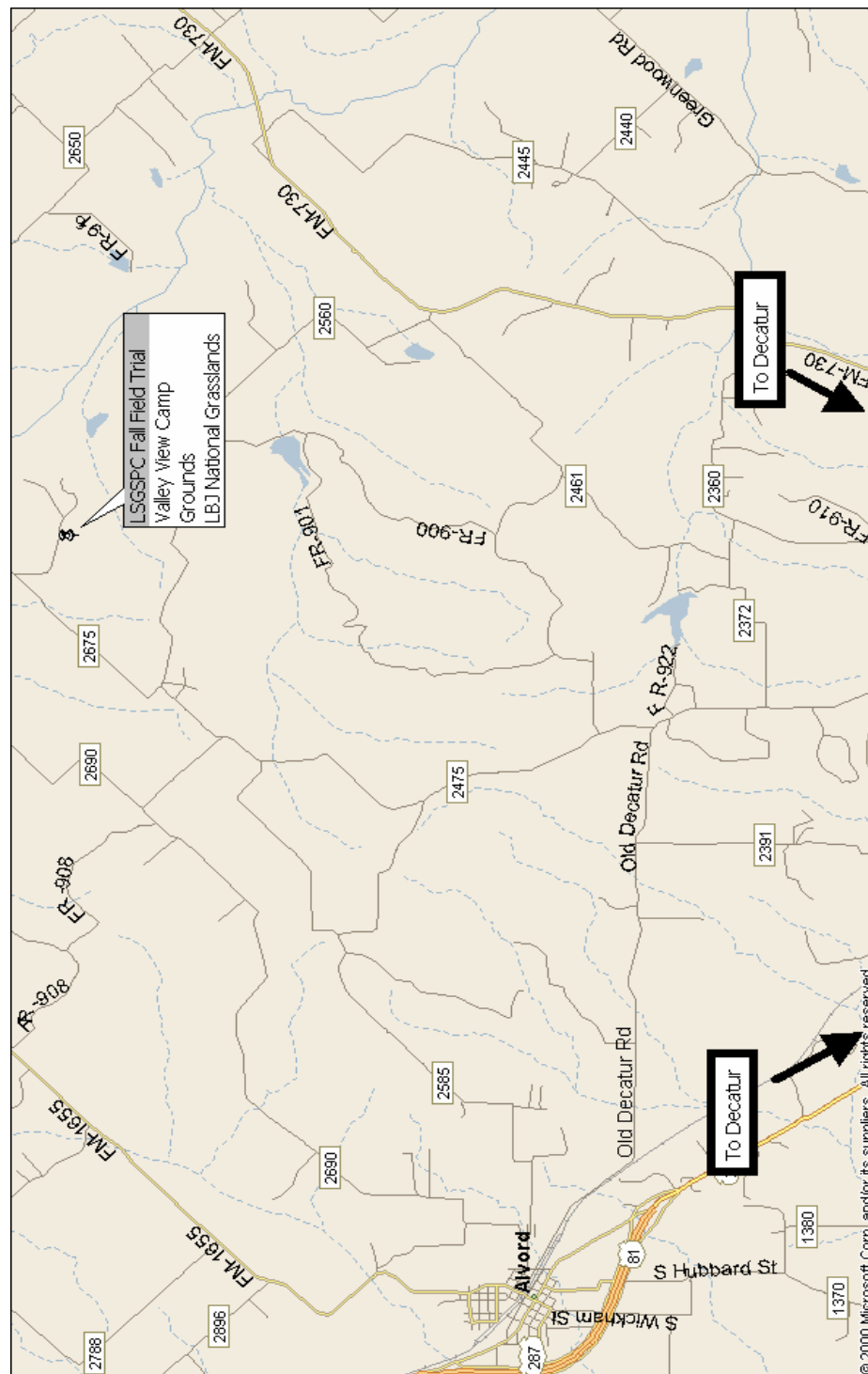

Driving Directions to the Field Trial grounds

Decatur Texas is 25 miles west of Denton on Hwy380 and Hwy287. Just east of the intersection of Hwy 380 & Hwy 287 is FM730. Take FM730 North 9.4 miles to CR2461. Turn left on CR2461, then turn immediate right on CR2560. Travel 4.7 miles to a "Y" in road, stay right for 1.5 miles more to CR2777. Turn right, go .4 miles to pavilion. Watch for LSGSPC event signs along the way.

Camping is allowed on the ground, however, no campfires, please. There are no facilities at the grounds other than an outdoor rest room.

A blank cartridge will not be fired in the Open Puppy stake. Call back to Retrieve in the Open Gun Dog and Amateur Gun Dog stakes. Bitches in season will be allowed to run in all stakes. Use of AKC approved tracking collars will be permitted. The locator for any collar used will be controlled by the Field Trial Marshall and will be activated only after a dog has been eliminated from contention. Any dog located by use of a tracking collar cannot placed.
